Wausau and Marathon County Park Foundation Meeting Minutes
August 19, 2025 - Dock at Wausau County Club, 208 Country Club Rd., Schofield.

Members present: Bill Bertram (President), Kevin Crooks (Vice-President), Randy Falstad, Jamie Polley, Bill Duncanson, Jeff Frese, Dan Bowen. Absent: Nicole Fandrey, Mike Egan,

- 1. President Bill Bertram called the meeting to order at 4:42 p.m.
- 2. Minutes: The minutes from the June 17, 2025 were reviewed. Bowen made motion to accepted the minutes. Crooks seconded. Motion carried by voice vote, no dissent.
- 3. Financial Reports: Treasurer Duncanson reported that he submitted the annual form to the State Department of Financial Institutions in early August. He stated that there was little to nothing to report as to changes in finances since our June meeting. Bertram reported that there is \$16,000 in the Water Trail amount. Bowen made the motion to accept the financial report. Frese seconded. Motion carried by voice vote, no dissent.
- 4. Great Pinery Heritage Waterway Trail: Betram reported that he is working on the development of campsites on the Water Trail. Foundation is looking for approval to build campsites on Menard and Bill Cross Islands in Lincoln County and on the Big Island on Lake Dubay in Marathon County. Once approval is received, the Scouts will develop the sites. Water Trail is also applying to add an additional 35 miles of trail.

#### 5. New Business:

• Fundraising and Sponsorship: Both Falstad and Bertram supplied information to the Board prior to the meeting on possible film festivals that they had obtained information on since the last meeting. Falstad had obtained contact information on the Wild and Scenic Film Fest and Bertram, the Baniff Film Fest. Both stated they were willing to investigate further as far as costs, etc. before the next meeting should the Board feel this would be a good fundraiser for our organization. The Board felt this was a very good opportunity for fundraising and Bowden even suggested the Board should think about doing both of the film festivals at different times of the year. The Board felt that we should

consider doing our first fundraiser in April of 2026. Because of that, it was suggested to move our next meeting up to October 7<sup>th</sup>, in order to keep moving forward with the idea. Falstad and Bertram both agreed to investigate the festival further and to get together and do some comparisons prior to the October meeting.

- Gravel Bike Roads: Bertram gave an update on a gravel road bike trail
  project. There is a guy who develops gravel road bike trails. It is not an
  Iron Bull project. Looking as a trail system for Marathon County with
  some of the trailheads being on County land. There would be 13
  trailheads.
- \$80,000 to promote the Water Trail. GWPP which is an offshoot of the Chamber.
- New Member Recruitment. Bertram stated he has asked a number of young people he thought might be good candidates for our Board and has struck out.

#### 6. Old Business

• IronBull – Bertram reported that in response to our discussion at our last meeting with the Executive Director of the IronBull, John Lauer, a certified letter would be coming from the IronBull to end the MOU that is currently in place between the IronBull and the Foundation. Falstad stated that he clearly remembered Lauer stating he was not going to just send us a letter and was going to talk to us. Polley reported as a way of a reminder that when the IronBull was created, and MOU was signed, IronBull was supposed to pay the Foundation 5% of all registrations from events. When the Foundation was paid in 2021, the Foundation realized they were not being paid per the contract and began to pursue getting answers from the, then Executive Director, Andrea. No answer came from IronBull. The Foundation received another payment in March 2023, with no supporting documentation. It was then the Foundation offered a proposed amended MOU. Again, the Foundation received no response from IronBull. Lauer stated at the June meeting that Iron Bull was considering giving us the funds from one event rather than

5% from all events in a new MOU. Falstad stated he would not be in favor of that as should that one event fade away, we would get no funds. Falstad asked if anyone has ever figured out how much IronBull owes us up to this point for previous registrations. The answer was no. Crooks stated that if IronBull wanted to come to new agreement, the Foundation, should ask for documentation of the net registration collected from all races put on by Ironbull since April 2019 and payment of the 5% prior to the Foundation considering a new MOU.

- Polley asked about Board service years.
- Duncanson reported that he had informed the Newby family of the tree we had purchased for Chuck Newby and had planted. They were very appreciative.
- Polley reported on the Skate Park Grand opening and how it was one
  of the best received openings she has ever witnessed.

The purpose of this project is to replace the chain link fence that encompasses the playing field. The existing fence is curling up at the bottom and becoming a safety hazard. Other areas of the fence are bent, bowed out or have been damaged from large falling tree branches. All in all, the fence has seen better days. It has served the community well, but it is time to retire the fence and replace it. My best guess for the age of the fence is 75-years old.

The Elderon Ballpark attracts softball, little league and baseball players from throughout Marathon County and beyond.

### **Project Narrative**

#### **Project Description\***

The project is centered around recreation and safety. The Elderon Ballpark is a beautiful facility, but the fence encapsulating it has exceeded its useful life. There are many areas where the bottom of the fence is curling up, which is a safety concern because it would be easy to trip on and cut yourself on the exposed bottom of the chain link fence. I've included pictures to document this concern. There are additional areas of the fence that have bowed out over time. Most likely caused by years of hitting balls into the fence during practice. I've included pictures to document this as well. The final area of safety is to increase the overall height of the fence to reduce the number of foul balls hit directly into the third base bleacher area. Over the years, we have had several foul balls hit spectators and many close calls along the third base line, as the height of the fence isn't sufficient enough to stop baseballs hit in that direction. The new fence will extend 10-feet, where the current fence is only 7-feet tall.

The objectives are to eliminate these safety concerns, while transforming the ballpark with a 10-foot tall encompassing fence. The taller fence will change the dynamics of the park for an improved level of play. Taller outfield fences will make play more challenging and will make the ballpark more relevant. The evolution of equipment (bats and baseballs), combined with the smaller dimensions of the Elderon Ballpark has made hitting home runs much easier, this new, taller fence will make it more challenging and will be a welcome change to the aesthetics of the park.

### **Duplication of Services\***

Are there any similar projects currently operating in the community? If so, how is your program different, and why is it needed?

Elderon Ballpark is the only baseball/softball diamond in the Village of Elderon. The setting is very unique and is considered one of the best ballparks in the area by many citizens of surrounding areas. Everyone loves playing here and watching games in our beautiful park setting. Our abundance of shade trees, our historic clubhouse, our concession stand and our playground area - the park is a treasure and the Village of Elderon spends significant resources every year maintaining and improving it.

The closest softball diamond to Elderon is about 10-miles away in Galloway, WI. That ball diamond is softball only. Wittenberg, WI is approximately 10-miles away from Elderon as well and Wittenberg has both a baseball and a softball diamond. The ball parks in Galloway and Wittenberg are used most of the summer - youth softball, adult softball, little league, legion baseball and adult amateur baseball.

(We have a lot of trees around the ballpark.)

This upgraded park will become a tournament-style facility, enhancing the local economic impact while hosting state and regional competitions with expanded baseball and softball fields, a skatepark area, walking paths, playgrounds, shaded areas, a new outdoor hockey rink, and additional parking to accommodate everyone. This project is phased with two fields being built this summer, one with lights. This investment will be used for lights on the second field. The lighting estimate for the second field is \$160,000-\$200,000. The total cost of the 10-year project is estimated at 14.5 million.

Kennedy Park, serving the Everest community for over 60 years, requires comprehensive renovation to meet the demands of modern youth sports and create a premier regional recreation destination. This \$14.5 million capital campaign will transform the 38.8-acre facility into a tournament-quality complex, featuring five new baseball/softball fields, concession stand, hockey facilities, walking paths, shade areas and upgraded facilities for year-round enjoyment. This project is a collaboration between the Village of Weston Parks & Recreation Committee/Department, the Community Foundation of North Central Wisconsin, D.C. Everest Youth Baseball, JV Baseball, Everest Fastpitch, JV Softball, and Everest Youth Hockey. The recent completion of Greenheck Turner Community Center and the tournament activity have created excitement for upgrading the park adjacent to the center. Key infrastructure improvements include:

- Five new fields with designated turf infields and lighting systems, ADA-accessible pathways and modern restrooms
- Expanded skatepark and outdoor hockey rink, centralized concessions and enhanced parking
- Scoreboards and dugouts

#### **Economic Development**

- Annual Tourism Revenue: \$1.2M+ from tournament weekends
- Regional Positioning: Central Wisconsin youth sports destination
- Local Business Growth: Increased traffic to hotels, restaurants, and retail
- Direct Beneficiaries: 1200+ athletes annually (baseball, softball, hockey)
- Tournament Capacity: 1,000+ visiting families per major event
- Equity Enhancement: Equal facilities for girls' and boys' programs
- Accessibility: Full ADA compliance for all community members

The Kennedy Park Capital Campaign represents a once-in-a-generation opportunity to create lasting community infrastructure that supports youth development, drives economic growth, and fosters regional pride. Our goal is to build five ballfields with modern lights, updated scoreboards, batting cages, and turf to accommodate girls softball and boys baseball from ages four through adults. Build a sheltered outdoor ice rink for hockey to use during the winter months for skating and for all to use during the summer months as a picnic shelter and roller hockey rink. Expand walking paths to accommodate families, strollers, and wheelchairs .This also includes new playground structures, sheltered picnic areas, shade canopies, and seating areas. By adding lights, more tournaments will be played during the summer, increasing the economic impact of the Weston/Wausau area filling hotels, utilizing restaurants, and not canceling due to weather.

DCE Youth Baseball is the only organization in the Weston area that offers REC baseball for boys/girls age 4-14. Youth baseball is the primary user group at Kennedy Park. Youth softball, JV softball, and JV baseball also use the fields. There is not a similar sports complex within 50 miles. Currently, when it rains, we cancel tournaments, causing a decline in the local economy and a strain on volunteer organizations. We cannot expand our program due to lack of field space, natural playing fields, Mother Nature and no lighting options. Facilities in Verona, Wisconsin Dells, Deforest and Pulaski are used as examples.

Friends of Kennedy Park is a collaboration between the Village of Weston Parks & Recreation Committee/Department, the Community Foundation of North Central Wisconsin, D.C. Everest Youth Baseball and JV Baseball, Everest Fastpitch and JV Softball, and Everest Youth Hockey. Each of these organizations has agreed to be a part of this project as we fundraise, plan, build and use the park. Many of our children, coaches, parents and leaders participate in all three sports and have a vested interest in the park. The park is property of the Village of Weston. The youth organizations for baseball, softball and hockey are each independent 501c3 and volunteer run.

DCEYB will continue to fundraise for the project with grants, raffle sales, special events, in-kind donations, restaurant nights, and business investments.




